Third Amendment To Contract CE0800040

This Amendatory Contract made and entered into this ____ day of _____, 2011 by and between the County of Cuyahoga, Ohio (the "County"), on behalf of the Cuyahoga County Common Pleas Court and the Cuyahoga County Corrections Planning Board (the "Court") and Advanced Psychotherapy Services LLC, an Ohio corporation, with principal offices located at 28916 Euclid Avenue, Wickliffe, Ohio 44092 for sex offender treatment services for the Common Pleas Court Adult Probation Department.

Witnesseth:

Whereas, Advanced Psychotherapy Services LLC entered into a Contract (County Resolution 074192) dated October 4, 2007 (hereinafter called "Contract") whereby the Advanced Psychotherapy Services LLC was awarded \$75,000.00 in funds for an activity entitled Sex Offender Treatment Services; and

Whereas, Advanced Psychotherapy Services LLC entered into an Amendatory Contract (County Resolution 093129) dated July 23, 2009 (hereinafter called "Contract") whereby the Advanced Psychotherapy Services LLC agreed to a decrease of \$16,000.00 in funds for an activity entitled Sex Offender Treatment Services; and

Whereas, Advanced Psychotherapy Services LLC entered into an Amendatory Contract (County Resolution 095132) dated December 17, 2009 (hereinafter called "Contract") whereby the Advanced Psychotherapy Services LLC agreed to an increase of \$22,200.00.00 in funds for an activity entitled Sex Offender Treatment Services; and

Whereas, the amount of the Contract reads;

\$81,200.00 for October 1, 2007 through December 31, 2010;

Now, therefore, in consideration of the mutual covenants and contracts herein contained, Advanced Psychotherapy Services LLC hereby agrees as follows:

- 1 Except as herein specifically amended, all terms used herein have the same meanings in the Contract.
- 2 The amount of the contract is increased by \$9,340.00 to \$90,540.00; The time period of the contract is extended from December 31, 2010 through February 28, 2011.


The Contract shall read:

\$59,000.00 for the time period October 1, 2007 through December 31, 2009 and
\$31,540.00 for the time period January 1, 2010 through February 28, 2011.

This amendment is necessary so that Advanced Psychotherapy Services LLC may provide additional treatment services to offenders placed into this sanction by order of the Court. This funding is provided by the Fiscal Year 2011 Community Corrections Act Felony Grant funds.

- 3 Except as herein specifically amended, all of the terms and provisions contained in the Contract are hereby ratified and confirmed and said Contract is hereby incorporated to the same extent as if fully rewritten herein.


