Proposals will be accepted until two o' clock in the afternoon (2:00 P.M.) local time on the Bid Due Date at which time and place the proposals received will be publicly opened and read aloud. The clock located in the Office of Procurement and Diversity shall determine the official time.

Per "ODOT's 2010 LPA Template – Required Contract Provisions" (see "Section 200: Special Provisions"), only ODOT pre-qualified contractors are eligible to submit bids for this project.

A pre-bid conference will not be held.

Copies of the BID PACKAGE which includes the PROPOSAL PACKAGE, the CUYAHOGA COUNTY ENGINEER SPECIFICATION BOOKLET, the PLANS and the STANDARD CONSTRUCTION DRAWINGS may be obtained at the Office of Procurement and Diversity for a non-refundable fee of \$110.00 paid in advance. Payment shall be made by a certified check or money order drawn on some solvent account payable to "Treasurer of Cuyahoga County, Ohio". Personal checks or cash will not be accepted.

Each proposal shall be accompanied by a bid guaranty, per ORC Section 153.54, in the form of either a bid bond for the full amount (100%) of the bid, or a certified check, cashier's check, or irrevocable letter of credit pursuant to ORC Chapter 1305 in the amount of ten percent (10%) of the total amount of the bid. If a bid bond is submitted as the bid guaranty, it must be that of an approved surety company authorized to transact business in the State of Ohio and it shall automatically increase to a 100% Performance and Payment Bond. If a certified check, cashier's check, or irrevocable letter of credit is submitted as the bid guaranty, it must be drawn on a solvent bank and made payable without condition to the Treasurer of Cuyahoga County.
