Third Amendment To Contract CE0701034
Dated October 4, 2007

This Amendatory Contract made and entered into this ____ day of _____, 2011 by and between the County of Cuyahoga, Ohio (the "County"), on behalf of the Cuyahoga County Common Pleas Court and the Cuyahoga County Corrections Planning Board (the "Court") and Psychiatric and Psychological Services, an Ohio sole proprietor, with principal offices located at 750 South Abbe Road, Elyria, Ohio 44035, for sex offender treatment services for the Common Pleas Court Adult Probation Department.

Witnesseth:

Whereas, Psychiatric and Psychological Services entered into a Contract (County Resolution 074192) dated October 4, 2007 (hereinafter called "Contract") whereby the Psychiatric and Psychological Services was awarded \$95,000.00 in funds for an activity entitled Sex Offender Treatment Services; and

Whereas, Psychiatric and Psychological Services entered into an Amendatory Contract (County Resolution 093334) dated August 6, 2009 (hereinafter called "Contract") whereby the Psychiatric and Psychological Services was awarded an additional \$9,000.00 in funds for an activity entitled Sex Offender Treatment Services; and

Whereas, Psychiatric and Psychological Services entered into an Amendatory Contract (County Resolution 095131) dated December 17, 2009 (hereinafter called "Contract") whereby the Psychiatric and Psychological Services was awarded an additional \$53,305.00 in funds for an activity entitled Sex Offender Treatment Services; and

Whereas, the amount of the Contract reads;

\$157,305.00 for October 1, 2007 through December 31, 2010;

Now, therefore, in consideration of the mutual covenants and contracts herein contained, Psychiatric and Psychological Services hereby agrees as follows:

1. Except as herein specifically amended, all terms used herein have the same meanings in the Contract.
2. The time period of the contract is extended from December 31, 2010 through February 28, 2011.


The Contract shall read:

\$104,000.00 for the time period October 1, 2007 through December 31, 2009 and
\$53,305.00 for the time period January 1, 2010 through February 28, 2011.

This amendment is necessary so that Psychiatric and Psychological Services may provide additional treatment services to offenders placed into this sanction by order of the Court through February 28, 2011. No additional funding is required for this amendment.

3. Except as herein specifically amended, all of the terms and provisions contained in the Contract are hereby ratified and confirmed and said Contract is hereby incorporated to the same extent as if fully rewritten herein.
