THIS AMENDMENT made and entered into this \_\_\_\_\_ day of \_\_\_\_\_, 2011 by and between the County of Cuyahoga, Ohio (hereinafter called the "COUNTY"), on behalf of the Cuyahoga County Juvenile Court (hereinafter called the "COURT") and The Glen Mills Schools, a Pennsylvania not-for-profit corporation, with principal offices located at 185 Glen Mills Road, Glen Mills, Pennsylvania 19342 (hereinafter called the "VENDOR")

WITNESS THAT:

WHEREAS, the COURT desires to engage the VENDOR'S professional and technical services to conduct programming, treatment, case management and care and custody services for juvenile male offenders.

NOW, THEREFORE, it is agreed that the contract by and between the COURT and the VENDOR for services to be rendered from June 1, 2010 to January 31, 2011 is hereby amended to include the following revision to sections:

- To increase the funds in the amount of \$350,000 00. This changes the not-to-exceed value of the contract from \$170,000 00 to \$520,000.00.
- To extend the contract for twelve (12) additional months, from February 1, 2011 to January 31, 2012
- ELECTRONIC SIGNATURES - By entering into this CONTRACT, the VENDOR agrees on behalf of the contracting business entity, its officers, employees, subcontractors, subgrantees, agents or assigns, to conduct this transaction by electronic means by agreeing that all documents requiring county signatures may be executed by electronic means and that the electronic signatures affixed by the COUNTY to said documents shall have the same legal effect as if the signature was manually affixed to a paper version of the document. The VENDOR also agrees on behalf of the aforementioned entities and persons to be bound by the provisions of chapters 304 and 1306 of the Ohio Revised Code as they pertain to electronic transactions, and to comply with the electronic signature policy of Cuyahoga County.

All other sections of the original contract shall remain the same.

IN WITNESS WHEREOF, the COUNTY, the COURT and the VENDOR have executed this AMENDMENT to the contract
